Hong Kong Ferry (Holdings) Co. Ltd.

The Hongkong & Yaumati Ferry Co. Ltd. (HYF) was established in 1923. It is part of Hong Kong Ferry (Holdings) Co. Ltd. (HKF), a listed company in the Hong Kong Stock Exchange, running diversified business including property development and investment, ship repair and maintenance, harbour cruise and ferry service.

HYF has been providing ferry service in Hong Kong for almost a century. Before cross harbour tunnels and metro were built, ferry was one of the most important modes of transportation in the city. HYF was a major ferry service provider to islanders. Going along with Hong Kong's development, HKF and HYF also adopt and develop themselves to cope with the changes. Ir. Willie Yeung, Deputy General Manager of HYF, will make a brief review of the company's history and its transformations throughout the years.

Fat Kee Stevedores Ltd.

Founded in 1949, Fat Kee Stevedores Ltd. (FKS) is a long established logistics operator in Hong Kong providing high quality services in land and sea transportation, distribution centre operations, supply chain solutions and waste logistics management. FKS has witnessed the changes of development in Hong Kong and itself transformed from a small set up which relied substantially on manual labour to today's multi-disciplinary organisation. In the presentation, FKS will share her experience on morphing itself with Hong Kong, and how it positions itself to tackle the challenges and grasp the opportunities ahead.
