HONG KONG MARITIME WEEK (HKMW) 2022 – COVERING ALL THE BASES

The highly anticipated HKMW (20-26 November 2022), organised by the Hong Kong Maritime and Port Board (HKMPB), is designed to illuminate the major developments in the maritime industry. During HKMW, local and international industry practitioners will participate in various physical, online and/or hybrid activities. Members of the public, in particular the youngsters, will get a glimpse of the industry through our wide array of fun-filled and educational activities.

Active participation by local and international organisations are key to the success of HKMW. Since its debut in 2016, HKMW has received overwhelming support from a number of local maritime organisations, such as GS1 Hong Kong, Institute of Chartered Shipbrokers (Hong Kong Branch), Maritime Professional Promotion Federation, Modern Terminals, The Chartered Institute of Logistics and Transport in Hong Kong, The Hong Kong Joint Branch of The Royal Institution of Naval Architects and The Institute of Marine Engineering, Science and Technology, etc.

New Highlighted Topics

HKMW 2022 will feature eleven themes, such as **“Building up of maritime talent pool”**. Building on Hong Kong’s vibrant port and maritime services cluster, Hong Kong strives to attract global talents to enrich our talent pool. **“Guangdong-Hong Kong-Macao Greater Bay Area (GBA) development”** is another driving theme in the HKMW. Hong Kong plays an important role in the GBA development. HKMW provides an ideal platform for industry leaders and professionals to share insight on the opportunities arising from the GBA development.

Building Up of Maritime Talent Pool
